# MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE HOUSING AUTHORITY OF THE COUNTY OF SANTA BARBARA June 15, 2023

The Board of Commissioners of the Housing Authority of the County of Santa Barbara met in regular session on June 15, 2023 at 815 West Ocean Avenue, Lompoc, CA. Chair Pearson convened the meeting at 5:00 p.m.

Upon roll call the following Commissioners were present: Shay Allen, Christian Alonso, Lisa Knox-Burns, Robert Doyle, Henry Mercado, Greg Ortiz, and James Pearson.

Also present were Bob Havlicek, Executive Director; Irene Melton, Director of Finance; Sanford Riggs, Director of Operations; John Polanskey, Director of Housing Development, Irene Vejar, Human Resources Director; Nancy Wesoff, Director of Contract Administration and Compliance, Surf Development and Teresa Ruffoni, Legal Secretary.

## INTRODUCTIONS

Executive Director Havlicek introduced Sylvia Bernard and Hector from Good Samaritan.

Chair James Pearson changed the order of items on the Agenda to accommodate the Good Samaritan guests:

## APPROVAL OF MINUTES

MOTION by Commissioner Doyle, seconded by Commissioner Mercado to approve the minutes of the regular meeting of May 18, 2023. All voted aye. Motion carried.

PUBLIC COMMENT PERIOD - No public comments were received.

## REPORT OF THE SECRETARY/EXECUTIVE DIRECTOR

Executive Director Havlicek reported on the renovation at the four plex in Guadalupe and noted preparations were being made to sell it to Surf Development. He received a very nice email from United Way saying they were very happy with our work. Director Riggs reported the details on the progress.

Executive Director Havlicek reported that Harry's House construction is scheduled to be completed on August 2<sup>nd</sup>, 2023. The Executive Director's report concluded. The Chairperson called for questions.

Commissioner Knox-Burns requested the status on the written responses to the public comments on the parking policy. Director Riggs reported the responses were still pending.

Director Riggs presented the status of the Waitlist for Harry's House. It opened April 18<sup>th</sup> and will close on August 31<sup>st</sup>, 2023. There are 212 applications for Harry's House. Currently we have selected 231 applicants.

Executive Director Havlicek reported that he has received emails on AB 8653 and they are on his radar. The bill introduction wants more accountability. Housing Authority's as a unit are assembling a response. HUD is aware. This is in the preliminary stages and has not passed the assembly. Chair Pearson called for questions. There were no further questions or comments.

Irene Melton reported that adjustments were being made to reduce accounts receivable. MOTION by Commissioner Knox Burns, seconded by Commissioner Ortiz to approve the operation and management reports. All questions were answered to the satisfaction of the Board. All voted aye. Motion carried.

### WRITTEN COMMUNICATIONS

Welcome Home Campaign - Good Sam presented information regarding clients and the services they provide. Many clients have no household items. Good Sam also helps by finding donations of necessities for those coming from homelessness to housing.

#### COMMISSIONERS' ORAL COMMUNICATIONS

Commissioner Doyle stated that he attended a presentation on a future development in the Orcult area.

## **NEW BUSINESS**

Executive Director Havlicek reported that Housing Authority has been helping fund Partners in Housing Solutions for years. The services provided have benefitted the Housing Authority's clients and landlords, and the partnership is value added.
